To whom it may concern,

We request a normal value review with regards to the Upholstered Domestic Seating for the following products from the vendor HTL.

Reasons for the Review

The review is requested because the original Normal values were calculated based on individual colours of the same cover. The models should have normal values based on the model and not the individual colours. This resulted in the same model having multiple different normal values based on colour. Other vendors that supply us have one duty per model with all colour options which are the same normal value. We would like the review to take into account that duties should be based on the model and grade of fabric or leather and not based on the colour only such as black or white as there is no difference in selling price or cost.

In addition to the colour issue. We are also asking for a normal value review for the sectional pieces. A sectional is sold as one unit and is made up of two pieces. Unfortunately the HTL models have individual duties for each piece of the sectional which are at different duties. Other vendors have the sectionals with a single duty that includes the individual pieces. We would like the review to consider the sectional to have a single duty based on the entire unit.

I have spoken with Walid Ben Tamarzizt and Jody Grantham from the CBSA with regards to these issues and was directed to contact you for the formal review process as they are in agreement that the colour should not be different for the normal values and that sectionals should be a single duty made up of multiple pieces. I understand you will be reaching out to HTL to get the most recent costs to determine the normal values. I have also updated them on our request for review so they can get the information to you to make the process easier.
