#### Chapter 80

# TIN AND ARTICLES THEREOF

## Subheading Note.

- 1. In this Chapter the following expressions have the meanings hereby assigned to them:
  - (a) Tin, not alloyed

Metal containing by weight at least 99% of tin, provided that the content by weight of any bismuth or copper is less than the limit specified in the following table:

#### (b) Tin alloys

Metallic substances in which tin predominates by weight over each of the other elements, provided that:

- (i) the total content by weight of such other elements exceeds 1%; or
- (ii) the content by weight of either bismuth or copper is equal to or greater than the limit specified in the foregoing table.

## Statistical Note.

(NB This note does not form part of the Customs Tariff legislation.)

1. For the statistical purposes of classification No. 8007.00.90.40, the description "subject to custom duty based on excise duty" means the items classified within this classification number contain an excisable good such as alcohol or tobacco, when being imported.
